

DECLARATION Affidavit cum Declaration

I Dhanna ram Jakhar S/o Narayan Ram Jakhar aged 62 years R/o A-8-B, Vinayak A, Kalwar Road, Gokulpura, Jhotwara, Jaipur, Rajasthan-302012 duly authorised by the promoter of the proposed project "KDMS SKYWALK" do hereby solemnly declare, undertake and state as under:

- 1. That promoter has a legal title to the land on which the development of the project is proposed.

- 9. That promoter has furnished such other documents as have been specified by the rules and regulations made under the Real Estate (Regulation and Development) Act, 2016.
