No. 247, 248/3, 250, 251, 252, 253, 254, 255, 256, 257, 258, 259, 260, 261, 262, 264, 265 at Balluru Village, Mayasandra O&M, Attibele Sub-Division by class-I Licensed Electrical Contractor as per the sanctioned estimate under the supervision of Asst. Engineer (Ele) / Asst. Executive Engineer (Ele), Attibele Sub-Division.

10% Supervision Charges of Rs. 10,57,798/- vide Rcpt No. 20160004832 Dated 04.11.2016 at 10% on the cost of the estimate is collected. No work order is assigned under any Head of Account of the Corporation to this work. This Certificate itself is treated as sanction for execution of work. After completion of work, joint inventory as prescribed vide Chief Controller of Accounts circular No. A0/Sa.4/Cys-10/92-93, dated 20-04-92 (page 246 of compendium vol.1) will be taken and asset accounted in the books.

The applicant has to maintain the following corridor width, based on the voltage of EHV line, if any EHT line passes through the layout/M.S Building.

66KV	220KV	400KV
18 mtrs (9 mtrs on either side from the center of the line)	35 mtrs (17.5 mtrs on either side from the center of the line)	51 mtrs (25.5 mtrs on either side from the center of the line)

The conditions agreed and undertaken in the undertaking submitted shall be adhered and complied.

As per Circular No. BESCOM/BC-33/ F-2338/ CYS-11/05.05.09 vide Sl. No. 15(a); the materials procured by the contractors for execution of total turnkey/ Partial turnkey and self execution, works shall be invariably be subjected to inspection by competent authority for its quality and specification as approved by BESCOM before commencement of works. The material placed by you is of 1-year guarantee and you have to maintain the same for 1 year.

Consequent to the amendment by the regulation by the Hon'ble KERC vide reference, the work shall be executed, completed and shall avail service within 90 days of this work order, else the application for power supply will be deemed as CANCELLED. On cancellation of the application, registration/re-registration cum processing charges shall stands forfeited.

NOTE:

Power sanction to an extent of 2855 KWs + 10HP(3369KVA) has been communicated from CEBRAZ vide under ref (1) and the applicant has paid the necessary supervision charges and cost of 14*250KVA transformers amounting to Rs. 58,58,512/- vide RT No. 20160004830 dated 04.11.2016 as per the sanction and amended regulations. The same has been confirmed by payment certificate of AEE, Attibele S/D. Work order for appropriate capacity of transformer required to provide power supply to any application registered shall be issued as & when need arises. This certificate is issued only for Extension of HT/LT lines & allied structures and install of transformer structure except providing transformer under self-execution. Separate Register shall be maintained for accounting the same as DCW.
