2. The said Erappa, son of Nanja Reddy, thereafter conveyed portion of Survey No.115, measuring 6 Acres 20 Guntas to C.Channaraya Gowda under Sale Deed dated 22.01.1934 (Document No.1).
3. C.Channaraya Gowda gifted the lands acquired by him in Survey No.115 under the Sale Deed dated 22.01.1934, which was reassigned Survey No.136 ("Survey No.136") to his daughters namely Savithramma, Akkamma and Lakshmamma, vide three separate Gift Deeds all dated 01.10.1965 (Document Nos.2 to 4) as follows:

Savithramma and Lakshmidevamma alias Lakshmamma along with Ramakrishne Gowda, availed loan from Large Sized Primary Agricultural Credit Co-operative Society Limited ("LSPACCS"), Kadugodi, against the scrutiny of their respective share in Survey No.136, under two separate Mortgage Deeds both dated 29.11.1968, (registered as Document No.3277/1968-69 and Document No.3280/1968-69 respectively) (Document Nos.5 and 8). As evident from the Discharge of Mortgage Endorsements both dated 26.07.1969 (Document Nos.6 and 9), that the said loan availed by (a) Savithramma and (b) Lakshmidevamma and Ramakrishne Gowda as to their respective share on 29.11.1968, have been discharged and paid back by Alembic Glass Industries Limited on behalf of Savithramma and Lakshmidevamma and the said mortgage deeds both dated 29.11.1968, in

this behalf stands fully discharged and the said discharges are recorded and registered vide Discharge Deeds/Receipts both dated 26.07.1969 (registered as Document Nos.1386/1969-70 and 1387/1969-70) (Document Nos.10 and 7).

5. Lakshmamma alias Lakshmidevamma, Akkamma and Savithramma thereafter sold Survey No.136, measuring 6 Acres 31 Guntas (including 8 Guntas of 'A' Kharab) to Alembic Glass Industries Limited ["AGIL"] under Sale Deed dated 26.07.1969 (Document No.11).

6. The Record of Tenancy and Crops Extract (RTC/Pahani) for the year set out below with regard to Survey No.136, discloses that the total extent as 6 Acres 31 Guntas and actual extent as 6 Acres 23 Guntas there being 8 Guntas of 'A' Kharab. 

7. The intermittent RTCs are not available, we have been informed. In our view the RTC of 1968-69 reflects the name of the predecessors-in-title of the present owners and thereafter the RTC is transferred to the name of Alembic Glass Industries Limited. Further, in our view, as the lands stood converted as far back as 1975 and is being used as non agricultural industrial use and assigned khata number by the Village Panchayat and as such non availability of RTC for the intermittent period in our view would not assume importance, save and except to corroborate ownership of Alembic Glass Industries Limited.




15. All that piece and parcel of agricultural land bearing (a). Survey No.115, Block 1 (part of Survey No.115) identified as Survey No.115/P1 and measuring 4 Acres and (b). Survey No.115, Block 2 (part of Survey No.115) identified as Survey No.115/P4, measuring 4 Acres, together in all measuring about 8 Acres, situated at Channasandra Village, Bidrahalli Hobli, Bangalore East Taluk (earlier Hoskote Taluk), Bangalore and is hereinafter for the sake of brevity and convenience referred to as "**Survey No.115/P1 and 115/P4**" belonged to Channaraya Gowda.

16. As security the lands in Survey No.22/2, 69 and 70 of Channasandra Village were given as security. We have been further informed that the company has not taken any ratification. 



COMMON DOCUMENTS:

33. On an application made by Alembic Glass Industries Limited and on payment of necessary conversion fines, the Special Deputy Commissioner, Bangalore District, converted Survey No.136, measuring 6 Acres 23 Guntas and the lands in Survey No.115/P1, measuring 4 Acres and 115/P4 measuring 4 Acres, from agricultural to non-agricultural industrial use vide an Official Memorandum dated 29.03.1975, bearing No.B.DIS.ALN.SR.335/1974-75 (Document No.50) and the said conversion of Survey 136 and Survey No.115/P1 and 115/P4, was confirmed by the Tahsildar, Hoskote Taluk thereby issued confirmation of possession to




Alembic Glass Private Limited vide Possession Certificate bearing No.ALN.SR16/1974-75 dated 29.05.1975 (Document No.51).

34. It is evident from the Order dated 21.03.1989, in case No.LRF 57/1987-88, on the file of the Tahsildar, Prevention of Unauthorised Construction Zone II, Hudson Circle, Bangalore initiated proceedings under section 79 B of the Karnataka Land Reforms Act 1974 had been initiated against Alembic Glass Industries Limited. On being heard and on verifying the documents/records produced by Alembic Glass Industries Limited, the Tahsildar, Prevention of Unauthorised Construction Zone II, Bangalore dropped the proceedings against the said Alembic Glass Industries Limited under section 79 B of the Karnataka Land Reforms Act (Document No.52).

35. On perusal of the Order dated 31.05.1989, in case No.ULC (A) (9) 123/1985-86, on the file of Additional Special Deputy Commissioner and Competent Authority, Urban Land Ceiling (Document No.53), discloses that the proceedings initiated against M/s.Alembic Glass Industries Limited as per the provisions of Urban Land (Ceiling and Regulation) Act, 1976 [“ULC Act”] and the said proceedings was dropped as the said M/s.Alembic Glass Industries Limited was not holding any excess of Urban Vacant Land. We would like to inform that Urban Land Ceiling Act stand repealed as of 22.03.1999 by virtue of the Urban Land (Ceiling and Regulation) Repeal Act, 1999. We have referred the ULC order to corroborate the ownership of M/s.Alembic Glass Industries Limited since then and prior thereto.

36. It is evident from the Form 9 extract issued by the Secretary, Channasandra Village Panchayat, Bangalore East Taluk, Bangalore (Document No.54) that converted Survey No.136 including parts of Survey No.115/P1 and Survey No.115/P4, together ad-measuring 14 Acres 23 Guntas, was assessed to tax by the Channasandra Village Panchayat and assigned Khata No.4 in the name of Alembic Glass Industries Limited and it also evident from the tax paid receipt that the tax has been paid for the year 2006-07 (Document No.55) by the Alembic Glass Industries Limited.

37. As per the scheme of amalgamation between Shreno Limited with Alembic Glass Industries Limited, the Hon'ble High Court of Gujarat at Ahmedabad in Company Petition No. 45 of 2006 connected with Company Application No.80/2006 (Document No.56), approved and sanctioned the scheme of amalgamation of Shreno Limited with Alembic Glass Industries Limited.




38. M/s. Alembic Glass Industries Limited resolved for the change in its name and as such changed the name from Alembic Glass Industries Limited to Shreno Limited and accordingly a Fresh Certificate of Incorporation Consequent upon Change of Name dated 19.09.2006, has been issued by Registrar of Companies, Gujarat, Dadra and Nagar Haveli (Document No.57).

39. The larger extent of Survey No.136, 115/P1 and 115/P4, together ad-measuring 14 Acres 23 Guntas, having come within the jurisdiction of the Bruhat Bangalore Mahanagara Palike was assessed to tax and was assigned BBMP Khata No.66/63, Kadugodi, Whitefield Sub-Division, Ward No.83, Bangalore , measuring 14 Acres 23 Guntas (the Larger Property) and M/s. Alembic Glass Industries Limited is recorded as the khatedar vide Khata Certificate and Khata Extract both dated 05.06.2014 (Document No.58 and 59) . We have not been furnished with the Special Notice assessing the larger extent of Survey No.136, 115/P1 and 115/P4 to tax by BBMP. This opinion is restricted to an extent of 11 Acres and 23 Guntas out of the said 14 Acres and 23 Guntas, being part of BBMP Katha No.66/63 of Kadugodi, Ward No.83, Whitefield Division, Bangalore, which comprises of 6 Acres 23 Guntas of Survey No.136 and 5 Acres of Survey No.115, Part 1 Block 1 and Survey No.115 Part 4, Block 2 which are shown in hatched green in the sketch annexed hereto ("the Property"). An extent of 3 Acres out of the total 8 Acres of 115/P1 and 115/P4, being the eastern side is not subject matter of this opinion.

40. The Search Report for the Larger Property for the period 01.04.1998 to 01.08.2014 (Document No.60) does not disclose any encumbrances.

41. The Village Map of Channasandra (Document No.62), shows the location, shape and boundaries of Survey No.136 and 115. As per the said Village Map, (a) Survey No.136, is bounded on the East by Survey No.116 and 117, West by Survey No.139 and 115, North by Survey No. 115 and on South by Survey No.115 and 117 and (b) Survey No.115 is bounded on the East by Survey Nos.96 and 117, on the West by Road, North by Survey No.139 and 136 and on the South by Survey No.96 and Road;

42. We had issued a public notice in two daily newspapers "The Hindu" (English daily issue) and "Udayavani" (Kannada daily issue) both dated 02.02.2013, (Document No.63 and 64) calling for objections, if any with regard to the Property i.e., Item Nos.1 and 2 and in response to such notice, we have not received any objections till date.

Shreno Limited has also applied for the No Objection Certificate from several governmental agencies (Document No.65 to 69) for construction on the Property. Based on such No Objection Certificate and the Master Plan being approved by the BDA , the BBMP on the application made by Shreno has accepted the payments for scrutiny of plans submitted by Shreno Document No.71) and the sanction of plans are awaited.

Taking into consideration the documents and information furnished and subject to observation made herein above, we are of the view that all that piece and parcel of property being portion of Bruhat Bangalore Mahanagara Palike Khata No.66/63, Kadugodi, Whitefield Sub-Division, Bangalore, Ward No.83, measuring about 11 Acres 23 Guntas (comprising of converted lands in Survey No.136 measuring 6 Acres 23 Guntas and 5 Acres being part of Survey No.115/P1 and 115/P4 both of Channasandra Village, Bidarahalli Hobli, Bangalore East Taluk) ("the Property") vests with M/s.Shreno Limited (earlier known as Alembic Glass Industries Limited) who are the absolute owners having good and marketable title, subject to tax being paid upto date. Shreno Limited by virtue of master plan from the BDA and on sanctioned plan approval from BBMP are entitled to take up construction of the building sanctioned on the Property.
