WHEREAS:

- The immovable property comprising of larger extent of land bearing Survey No. 139/2 measuring 1 Acre 1 Gunta excluded 4 Guntas of Phut Karabh, situated at Kammasandra Village, Attibele Hobli, Anekal Taluk, Bangalore Urban District, which was earlier owned by one Venkatamarappa father of the aforesaid parties. After the death of Venkatamarappa his son V. Venkatesh inherited property through the oral Partition.
- As per the oral partition property was divided in three portions i.e the First Party got 18½ Guntas out of 1 Acre 1 Gunta, the Second Party got 21½ Gunta out of Guntas out of 1 Acre 1 Gunta and the rest 1 Gunta is in the name of Third Party.
- The Second party the younger brother of First Part filed a suit dated 01/03/1992 O. S. No. 49/1992, before PRL/ADDL Judge, Bangalore for seeking his share in Family Property. Now in the view of the settlement arrived in between the parties and entered Compromise Decree bearing No. 49/1992 dated 26/03/1996, as per the Compromise Decree First and Second Party got equal share in 1 Acre 5 Gunta i.e 21½ each including with 4 Gunta phut kharab and Third party got 2 Guntas respectively. Totally 1 Acre 5 Guntas included Karabh, as per the Akarbandh and RTC Karabh 4 Guntas is B Karabh i.e lane which is not adaptable.
