1. Reference is made to your application for issuance of NOC for construction of multi-storied residential building located on No1, Nookkampalayam road, Semmanchery, Chennai-600 119.
2. Guidelines for issue of NOC has been issued by MoCA vide Gazette notification GSR 751E dated 30 Sep 15 to ensure time bound clearances for projects/ infrastructure under 'Ease of doing Business'. Colour Coded Zoning Maps (CCZM) have been formulated to assist decision making by Local Municipal Authority (LMA) based on the distance of the proposer infrastructure from IAF airfield.
3. The details of the proposal w.r.t nearest runway end of AF Stn Tambaram are as follows.


