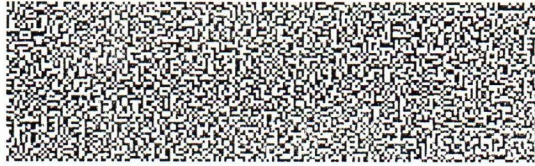
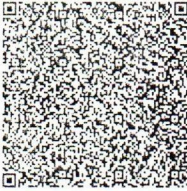

We, the Developers; and we, the Landowner (Developer and Landowner are collectively referred to as "Promoters", unless the context requires otherwise) of the proposed project presently named, **"THE ROOTS"** do hereby, jointly, and severally as the context requires, solemnly declare, undertake and state asunder:

1.
