Gentleman,

With reference to above, the amended plans submitted by you for the Rehab building are hereby approved by this office subject to following conditions.

- 1. That all the conditions mentioned in LOI under No. SRA/DDTP/0048/L/PL/LOI dated 27/09/2010 and revised LOI conditions dated 01/07/2015 shall be complied with.
- 2. That all the conditions mentioned in IOA under No.SRA/DDTP/525/L/PL/AP dtd. 23/02/2009 and amended IOA issued on 22/06/2015 shall be complied with.
- 3. Proposed changes shall be shown on canvas mounted plan to be submitted at the time of OCC/BCC.
- 4. Revised Drainage approval shall be got approved as per amended plan.
- 5. Revised R.C.C. design and calculations as per amended plan shall be submitted before requesting C.C. re-endorsement.
- 6. That you shall submit stability certificate before and after demolish of part portion of the building from I.I.T. Mumbai/V.J.T.I. before requesting C.C. re-endorsement of C.C. of the building as per proposed amended plans.

- That the demolish work shall be carried out under the strict supervision of Registered structural consultants and the same shall be got certificate from I.I.T. Mumbai/V.J.T.I.
- 8. That you shall submit Registered undertaking stating therein that you will not misuse parking spaces/as against the required parking spaces along with D.G. set room, Panel room, Electrical room, U.G. Tanks, Pump rooms & STP in the basement and ornamental projection of glass façade/glazing.
- 9. That you shall provide cross beam in 2nd & 3rd level basement is at 3.90 mt. level before requesting C.C. re-endorsement or further C.C. to building under reference.
- 10. That you shall submit the NOC from Dy.ChE. (M&E) as regards the ventilation of basement before re-endorsement of C.C. as per proposed amended plans.
- 11. That you shall install CCTV at site before starting of the work in construction with I.T. Officer (SRA).
- 12. That you shall submit NOC from concerned electric Co. as regards the size and location of meter room before requesting further C.C. of building under reference.
- 13. That you shall submit the NOC from H.E. Department as regards water will be supplied through pneumatic pump system directly to the tenements.
