Affidavit cum Declaration of Mr./Me. Abdul Rehman Banegar promoter of the proposed project / duly authorized by the promoterof the proposed project, videits/his/their authorization dated 20/08/2024.

i, Mr. Abdul Rehman Banegar promoter of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

 That I/promoter have/has a legal title Report to theland on which the development of the project is proposed

## AND

A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- That the project land is free from all encumbrances.
- That the time period within which the project shall be completed by me/promoter from the date of registration of project is on or before 31st accesses 2024 Proposed Extension Date (Original date of completion was 30th JUN 2024).
- a) that the grant of extension of the project validity shall not affect/jeopardize
  the rights accrued in favour of the allottees who have booked their unit or apartment
  in the said project for which extension of project validity is sought.
  - that we shall be bound by the terms and conditions as may be imposed by the MAHARERA authority in the interest of the allottees.
  - that the decision of the MAHARERA Authority should be final & binding upon the promoter(s).
- (a) For new projects:

That seventy per cent of the amounts realised by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- (b) For ongoing project on the date of commencement of the Act
- (i) That seventy per cent of the amounts to be realised hereinafter by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account tobernaintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

OR

(ii) That entire of the amounts to be realised h hereinafter by me/promoter for the real estate project from the allottees, from time to time, shall bedeposited in a separate account tobe maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.

That the amounts from the separate account shall be withdrawn in accordance with Rule 5

That I / the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicingChartered Accountant, and it shall be verified during the audit that the amounts collected for a

particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- That I /the promoter shall take all the pending approvals on time, from the competent authorities.
- That I/ the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.
- That I / the promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

 That I/the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
