3. We estimated Total Estimated cost of completion of the aforesaid project under reference at **Rs. 1,26,19,35,254** (Total of Table A and B) at the time of registration. 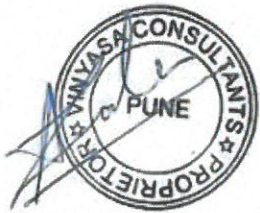
