

## **Affidavit cum Declaration**

Affidavit cum Declaration of Mr. Bhalchandra Kashinath Patil, duly authorized by the promoter of the proposed project "Purvanchal Co-Operative Housing Society Limited" vide his authorization dated 30th day of July, 2017 M/s. Kamalnath Universal Private Limited having registered office at 501, Thacker Tower, Sector 17, Vashi, Navi Mumbai-400 703 a Private Limited Company incorporated under Companies Act, 1956 (hereinafter referred to as "Promoter") do hereby solemnly declare, undertake and state as under:

That the Promoter is entitled to develop and construct building on a parcel of land admeasuring 517 sq. mtrs., bearing Plot No. 189, lying being and situated at Navghar Road, Mulund-(East), Taluka-Kurla, and in the Registration district of Mumbai and Mumbai Sub-urban District (herein after referred to as "Land").

M/s. Purvanchal Co-Operative Housing Society Limited has a legal title Report to the land on which the development of the proposed project is to be carried out AND

A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- 3. That the project land is free from all encumbrances and there are pending litigations, the details of which are annexed herewith in "Annexure 1".
- 4. That the promoter shall complete the project on or before 31st December, 2025.
- 5. That seventy per cent of the amounts to be realised hereinafter by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 6. That the amounts from the separate account shall be withdrawn in accordance with Rule 5.
- 7. That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

11. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case maybe.


