After the scrutiny, RERA has asked me to produce the Conversion Order. Accordingly, I am submitting you that the said land where the project is going on has already obtained the Municipality No:272 and BBMP Ward No:100. The said land was acquired by BDA for the purpose of formation of RAJAMAHAL VILAS EXTENSION 11 STAGE LAYOUT and later the acquisition order has been quashed by High Court order dt:01-07-2009. After the Writ Order, the endorsement dt: 26-02-2010 and 13-01-2011 has been given by Bangalore Development Authority saying that the acquisition proceeding has been taken back with respect to the Sy.No:36/1, 36/2 and 36/4 measuring 0.25 guntas and Sy.No: 36/2 measuring 0-15 guntas.
