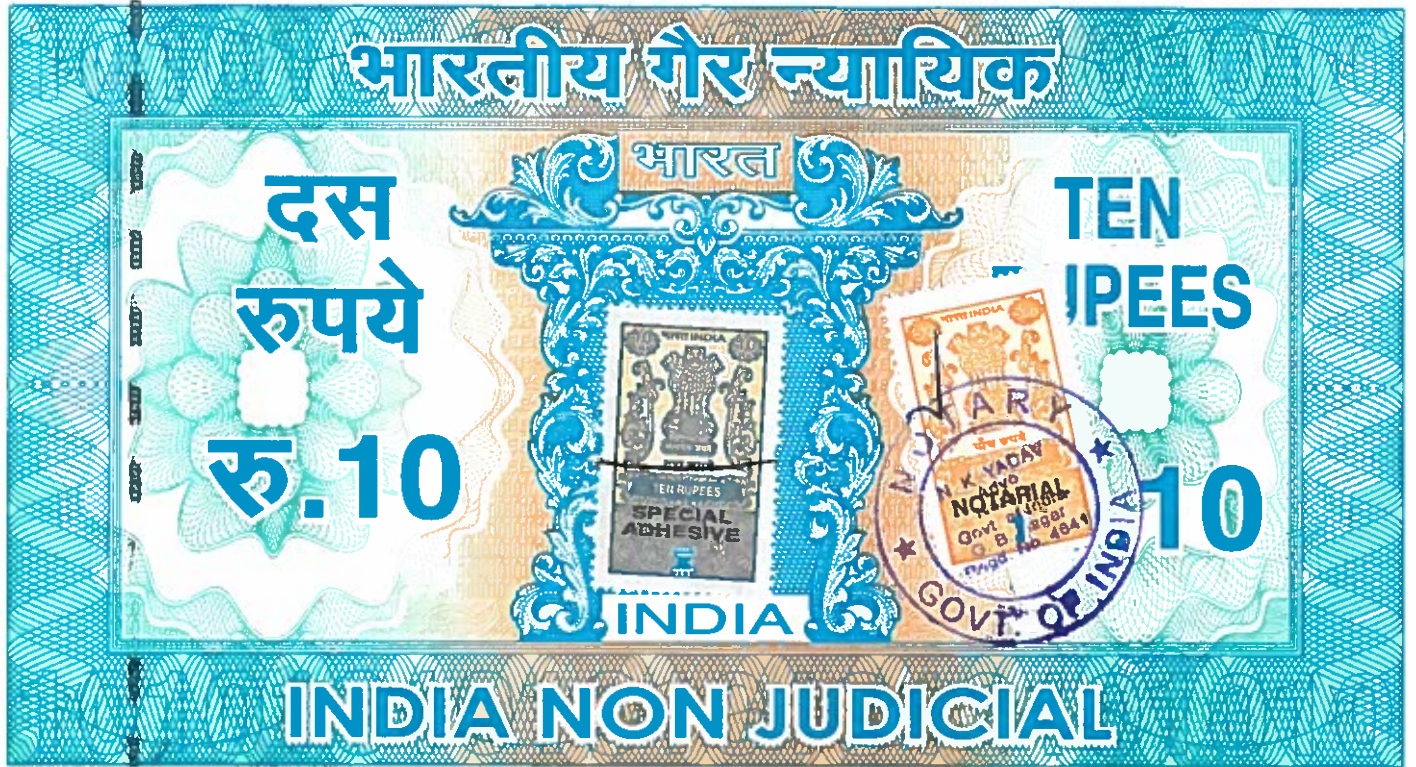

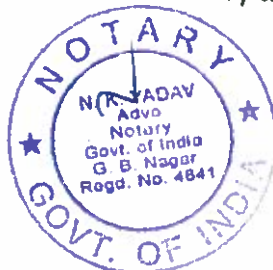

DECLARATION

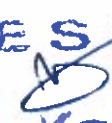

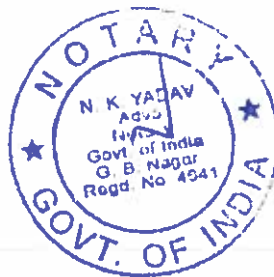
