Your site is located at a distance 10312 mts from ARP and lies in the grid FF7 of the published CCZM of Bangalore airport. The Permitted top elevation for this grid is 1010 mts.

Since the requested top elevation 974 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

- 3. This assessment is subject to the terms and conditions as given below:
