Your site is located at a distance 9088 mts from ARP and lies in the grid V11 of the published CCZM of Jakkur airport. The Permitted top elevation for this grid is 1035 mts.

Since the requested top elevation 950 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
