- 8. That, promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That, Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That, Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
