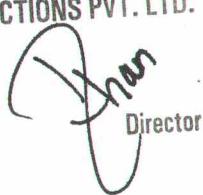

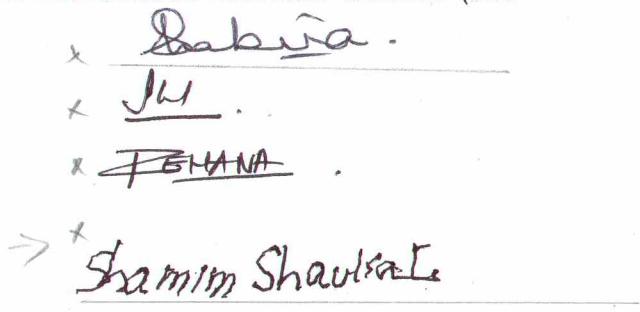

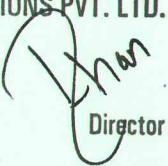
1. That We / promoter have entered into joint development agreement with land owners and Life Interest holder who possess a legal title to the land on which the development of the proposed project is to be carried out
