Sub: TNUHDB– Pradhan Mantri Awas Yojana (PMAY) – Housing for All scheme (HFA) - Affordable Housing Project (AHP) – **Pillaiyar Koil Thottam in Mylapore**, Division V, TNUHDB – Undertaking for land ownership in-favour of TNUHDB - RERA approval – Requested - Regarding.

I would like to invite your kind attention to the reference cited, for the reconstruction scheme at Pillaiyar Koil Thottam in Mylapore, which is pending for RERA registration due to land ownership issue.

The Pillaiyar Koil Thottam scheme is comprised of S.No. 3545/1 part, with a total extent of 0.6023 Hect., (6023 sq.m/1.488 Acres). The above said land lies with the ownership of Arulmigu Kabaleeswarar Thirukoil.

TNUHDB have constructed 240 tenements in G+3 development in Pillaiyar Koil Thottam during the year 1976-1977. Due to the dilapidated condition of the building it was proposed for reconstruction.

In this context, it is stated that, existing 240 dwelling units have been demolished & 308 dwelling units (306 Residential units + 2 unit reserved for refuge area) are proposed for reconstruction under PMAY (HFA) – Affordable Housing in Partnership (AHP).

Regarding the land ownership, the sale deed has been executed in-favour of TNUHDB by HR & CE department after the payment of Rs.1, 89,108/- (Rupees One Lakh Eighty Nine Thousand One Hundred and Eight only) towards land cost and land is in possession of TNUHDB. Further, a proposal has been sent by TNUHDB to the Tahsildar, Mylapore Taluk for the change of name in TSLR in-favour of TNUHDB.

In all the EWS schemes and reconstruction schemes, the land shall be retained by TNUHDB and only the housing units are given the sale deed. Considering all the above, as the sale right of the land lies only with TNUHDB and not sold to the public, it is requested that, the RERA registration may kindly be accorded for the scheme at

Pillaiyar Koil Thottam in Mylapore which will facilitate to obtain fund from Government of India (Gol) and help to commence the scheme without any further delay.

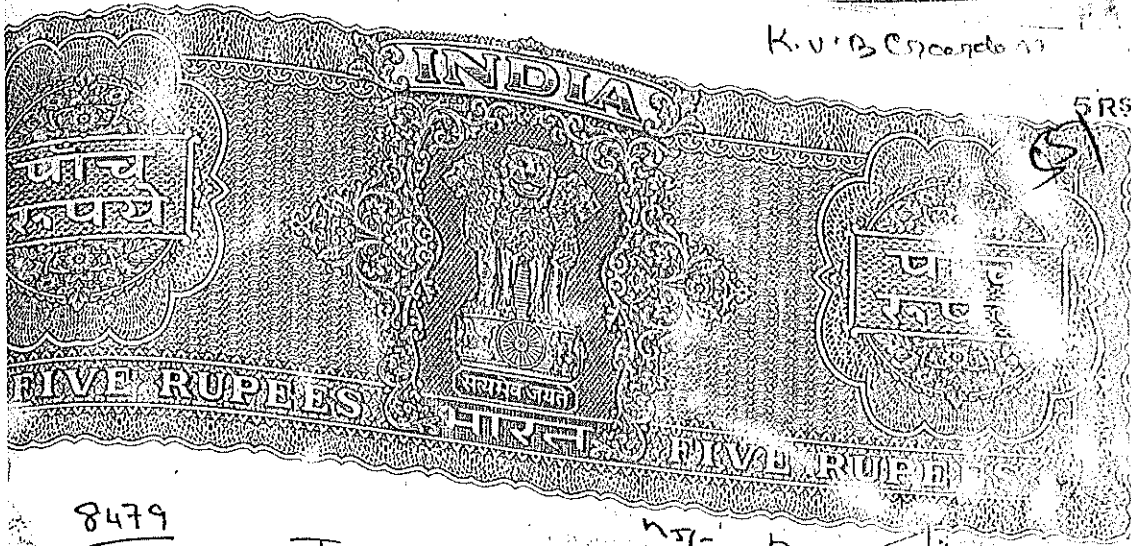
