

I, Sujeet Tripathi Son of Shri Shayam Narayan Tripathi aged 47 years R/o 66 B E-4, MIG Sector 82, Gautam BudhaNagar Noida, Uttar Pradesh-201301 duly authorized by Eldeco Infrastructure And Properties Limited ('Promoter') do hereby solemnly declare, undertake and state as under:

- 1. That the Promoter has a legal title to the Project Land on which the development of the project is proposed.
- 2. That the Project Land and receivables therefrom has been mortgaged in favour of HDFC Bank Limited against the credit facility availed by the Promoter.
- 3. That the time period within which the Project, as the case may be, shall be completed by Promoter is **30-06-2022**.
- 4. That seventy per cent of the amount realised by Promoter for the Project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the Project, shall be withdrawn in proportion to the percentage of completion of the Project.
- 6. That the amounts from the separate account shall be withdrawn only after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the Project.
- 7. That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular Project have been utilized for the Project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
- 8. That the Promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the Promoter has furnished such other documents as have been specified by the rules and regulations made under the Real Estate (Regulation and Development) Act, 2016.
- 10. That the Promoter shall not discriminate on the basis of caste, religion, region, language, sex or marital status against any allottee at the time of allotment of any apartment, building, as the case may be, on any grounds.
