With reference to the above, NOC is hereby issued to the proposed for 400KVA load to the residential apartment in favour of M/s MEGA BUILDERS, No.39 SY No.72/2 SRS Road, Peenya, Bengaluru-58 in Peenya O&M unit, N5 Sub-Division to an extent of 352 KVA(300KW) subject to the following conditions:-

- 1. Main source will be arranged from 66/11 SRS MUSS, 1\*31.5MVA + 1x20 MVA, 70MWs, B-2, 16.5 MW, F-13 feeder of Peakload 2.1 MW by using 3\*95sqmm UG cable (0.100Kms from premises) with New Compact RMU 2OD+1VL near proposed.
- 2. Alternate source also from 66/11 SRS MUSS, F7 feeder from loop cable.
- 3. You have to carry out all necessary works on self execution basis as per the estimate to be prepared by BESCOM by paying necessary supervision charges on 05% of the total cost of estimate.
- 4. While applying for power supply to the said premises, all rules as per KERC Electricity supply and Distribution code shall be observed.
- 5. You have to obtain approval from the electrical inspectorate, Govt. of Karnataka and same should be furnished while availing power supply if necessary.
- 6. This NOC is issued only for the purpose of obtaining sanction of plan from BDA/BBMP/Competent authorities and is not a commitment of power sanction from BESCOM. The power will be sanctioned subject to feasibility and as per rules prevailing at that time.
- 7. The existing L.T. Installations if any have to be surrendered before taking up the infrastructure work of the proposed Building.
- 8. If any KPTCL/BESCOM lines are passing through the above premises the same shall be shifted at your cost. This NOC does not apply to the premises where EHT lines are passing through your premises for which NOC is to be obtained from the concerned authorities.
- 9. BESCOM shall not be held responsible for any liability arising from the issue of NOC.

10.This NCC shall be produced at the time of availing permanent power supply to the above building.
