- 12. That you shall submit revised remarks from E.E. (T &C) of MCGM for parking layout and NOC from E.E. (M & E) for mechanized stack parking before full C.C. as sale wing 'B'.
- 13. That revised RCC design drawings and calculating as per amended plans shall be submitted before asking further C.C. as per plans.
- 14. That the shear well technology shall be adopted for design and construction of the building.
- 15. That you shall in stall C.C. T. V. camera with direct feed to SRA server at site as may be direct by I.T. department SRA.
- 16. That the L.S. shall submit quarterly progress report to Slum Rehabilitation Authority.
- 17. That you shall pay the difference in premium due o change in land rate
- 18. That the requisite premium, development charges, infrastructure charges/maintenance deposit shall be paid before requesting for C.C.
- 19. That the requisite extra water & sewerage charges shall be paid before requesting for OCC.
- 20. That the C.C. shall be got endorsed as per amended plans.
- 21. As per Circular Wo.130, Cess of one percent of total cost of construction (excluding land cost) shall be paid before grant of C.C.
- 22. That you shall hand over the balance PAP tenements before requesting full O.C.C. to sale wing 'B' of composite building.
