absolute authority to assure the said property here-
by assured or expressed to be unto and to the
use of J. Mangamma (signed in the original
in Telugu) 5 the purchaser absolutely and
that the purchaser shall and may at all times here-
after peaceably and quietly possess and enjoy
the said property receive and recover the rents
and profits thereof without any lawful let or hin-
derance or suit eviction or claim or demand by
persons through whom the Vendor derives title
either immediately or remotely or any person
or persons claiming through or under the Vendor
and that she shall and may enjoy and possess
the said property free from all encumbrances
made occasioned or suffered by the Vendor or any
