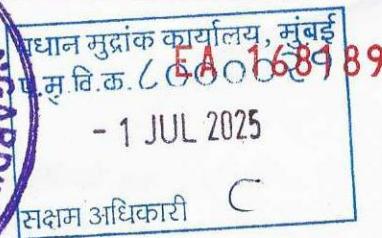
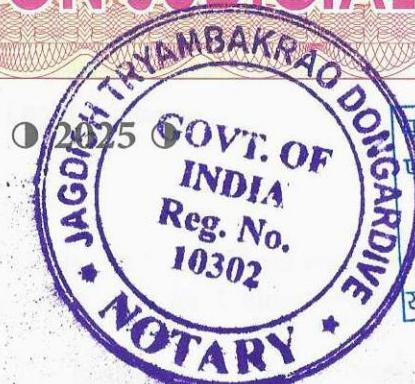

6. 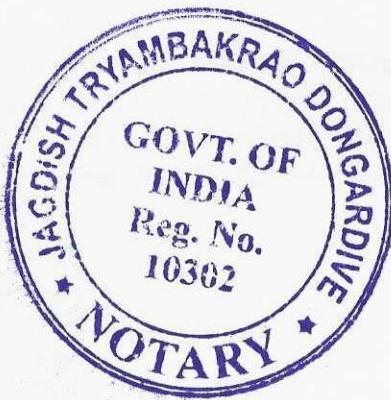
