



1. That we promoter have a legal title Report to the land on which the development of the proposed project is to be carried out
AND
a legally valid authentication of title of such land along with an authenticated copy of the agreement between, **Adityaraj Infinity Developers** and us for development of the real estate project is enclosed.
2. That the project is free from all encumbrances.
3. That the time period within which the project shall be completed by me/promoter is 31/12/2029.
4. That seventy per cent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

8. That I shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

10. That I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building as the case may be.




