- 5) That adequate safeguards shall be employed in consultation with SWM Dept. of MCGM for preventing dispersal of particles through air and the construction debris generated shall be deposited in specific sites inspected and approved by MCGM.
- 6) That the debris shall be managed in accordance with the provisions of Construction and Demolition Waste Management Rules 2016 and requisite Bank Guarantee as demanded by MCGM for faithful compliance of Waste / Debris Management plan shall be furnished before demolition of structures or construction work and BG shall be revalidated from time to time till granting OCC to this office.
- 7) That all the payments shall be made
- 8) That the C.C. shall be got re-endorsed.
- 9) That the Workmen compensation policy/ Janta Insurance policy shall be submitted.
- 10) That ESC charges shall be paid
