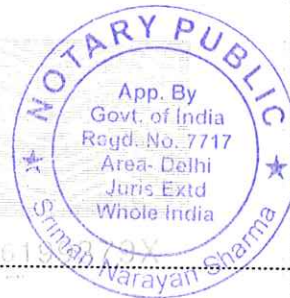

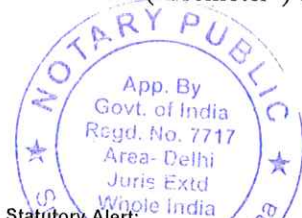

I, Ajay Kumar Singh, Director of the Promoter, whose registered office is situated at 201-212, 2nd Floor, Splendor Forum, Jasola District Centre, New Delhi 110025, which is developing a proposed Group Housing project on land admeasuring 29,833.105 sq. mt. ("said land") namely "Eldeco 7 Peaks Residences" situated at Plot no. GH-01 and GH-01/A, Sector – Omicron-01A, Uttar Pradesh ("Project") hereby solemnly declare, undertake and state as under:

1. That the Promoter has a legal title to the Project land on which the development of the proposed project.
2. That the said land of the proposed Project along with its receivables is mortgaged/ hypothecated in favor of Vistra ITCL (India) Limited acting as debenture trustee on behalf of HDFC Capital Affordable Real Estate Fund -3 and HDFC Capital AIF - 3 Scheme 2, for the purpose of raising finance. The necessary documentation for the charge creation with MCA website is under process.
3. That the time period within which the Project shall be completed by the Promoter is **14th November, 2030**
4. That seventy percent of the amounts realised by Promoter for the Project from the allottees, from time to time, shall be deposited in a separate account to maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only that purpose.
5. That the amounts from the separate account, to cover the cost of the Project shall be withdrawn in proportion to the percentage of completion of the Project.
6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the Project.
7. That Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
8. That Promoter shall take all the pending approvals on time, from the competent authorities.
9. That Promoter have/has furnished such other documents as have been prescribed by the Rules and regulations made under the Act.
10. That Promoter shall not discriminate against any allottee at time of allotment of any apartment, plot or building; as such case may be, on any grounds.
